**PSCU Financial Fitness Sweepstakes (“Sweepstakes”)**

**2021 OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. Subject to all applicable federal, state and local laws and regulations.**

- 1. ELIGIBILITY REQUIREMENTS:** Open to legal residents of the 50 United States, the District of Columbia who are 18 years of age or older and are registered account holders in good standing at a participating Financial Institution (defined below). The following are not eligible to enter or win a prize: employees, contractors, directors and officers of Fiserv Solutions, LLC (the “Sponsor”), PSCU and their respective parent companies, subsidiaries and affiliated companies, distributors, web design, advertising, fulfillment, legal, judging and sweepstakes agencies involved in the administration, development, fulfillment and execution of this Sweepstakes (collectively, “Sweepstakes Parties”), and the immediate family members of each (spouse, parent, child, sibling, grandparent, and spouse or "step" of each) and those living in their same households (those persons whether related or not who live in the same residence for at least three months during the twelve-month period preceding the start date of the Sweepstakes). - 2. SWEEPSTAKES PERIOD:** Sweepstakes begins at 12:00:01 a.m. Eastern Time (“ET”) on August 1, 2021 and ends at 11:59:59 p.m. ET on September 30, 2021 (the “Sweepstakes Period”).
- 3. TO ENTER:** There are two (2) methods of entry into the Sweepstakes.

First Entry Method - Online: Account holders in good standing (not in default under their agreement as of September 30, 2021) at a participating Financial Institution (“FI”) (as defined below) will receive one (1) entry into the Sweepstakes for each one (1) of the following actions made during the Sweepstakes Period (each a “Qualifying Transaction”).

- Qualifying transactions (Bill Pay):
  - Add and Pay a New Bill Pay Payee using RXP Online Bill Pay.
    - New Payee must be added during the sweepstakes period.
    - Payment must be scheduled and completed during sweepstakes period.
    - Bill Pay payment must be \$10 or more.
  - Set up a new Autopay or Recurring model and schedule payment during the sweepstakes period.
  - Activate a new eBill during sweepstakes period.

Details on Qualifying Transactions: Services offered at the various FI's vary. All Qualifying Transactions must be completed during the Sweepstakes Period. Qualifying Bill Pay transactions must be at least \$10 and must be sent to a unique party with a different mailing address from the Bill Pay subscriber; payments to oneself are excluded. A qualifying subscriber is a subscriber who is completing a qualifying transaction for the first time or a new qualifying behavior. All entrants must be the primary account holder of the Financial Institution account associated with the action used to enter. In the event of a dispute as to who submitted an entry, the natural person associated with the email account used for entry will be considered the entrant, but only if that person is otherwise eligible to enter the Sweepstakes

**Automated means of entry are prohibited and any use of automated devices to enter or subvert the entry process will result in disqualification and all associated entries will be void.**

**Second Entry Method:** If you do not have an account or do not want to enter via the methods outlined above, you may enter the Sweepstakes by mail. Limit one (1) entry per postage-stamped postcard. Mail-in entries must be handwritten and postmarked by September 30, 2021 and received by October 8, 2021. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. No mechanical reproductions will be accepted. Sponsor is not responsible for lost, late, illegible, invalid, misdirected, mutilated, incomplete, or postage-due mail/entries, which will be disqualified. Mail-in entries become property of Sponsor and will not be returned.

By participating, entrants agree to Official Rules and the Sponsor's decisions, which are final and binding in all respects. **4. **Five (5) Grand Prizes:** \$2,000 awarded in the form of a check made payable to each winner.

**Total value of all Grand Prizes: \$10,000.**

**6. PRIZE RESTRICTIONS: Limit one (1) prize per person/household.** Prizes are non-transferable and no prize substitution permitted. Winners are solely responsible for any taxes on the prize and will be issued an IRS Form 1099 for the Grand Prize value. As a condition of winning, the potential winner will be required to complete a W-9 Tax Form and will be required to furnish his/her social security number for the purpose of preparation of any tax forms as required by law. All costs and expenses associated with prize acceptance and use not specifically provided herein are the responsibility of the winner.
